This morning the Assistant Commissioner Mark Rowley who is the National Lead for Counter Terrorism and head of the Metropolitan Police Service Specialist Operations spoke to Industry Sector Leads on a CSSC Bridge Call to update them on the current threat from international terrorism and activity that will take place as part of Counter Terrorism Awareness Week. - This increased level of activity is matched by **increased action by the police and security services**, who are currently working on 600 active investigations and making an arrest a day;
- In the last 12 months **six attempts to carry out an attack have been thwarted** by the security services and police;
- Our **work with communities and local partners** to stop people getting involved in terrorism is **making a difference**, with 600 referrals a month and key interventions taking place to disrupt extremist activity;
